Boarding Agreement

I understand you can not guarantee the health of <animal> I understand and will not hold the clinic responsible for conditions that are unavoidable in boarding kennels, such as but not limited to weight loss, hair loss, upper respiratory infections, bronchitis, diarrhea, and fleas. I understand all pets admitted to the clinic must be protected against communicable contagious diseases and must be free of internal and external parasites or will be treated on entry or discovery at the owner / agent's expense.

I understand that in the event of <animal>'s illness, the staff will make every reasonable attempt to contact me or my agent to discuss the problem and treatment options.

If the staff is not able to contact me please proceed in the following manner:

_____ Please treat <animal> as indicated, including non-emergency conditions (e.g. skin problems, eye problems, etc) you need not call me. I agree to pay in full, all charges associated with the diagnosis and treatments deemed necessary by the veterinarian.

_____ Perform only emergency and supportive care. Notify me for permission to begin any other treatment.

Should an **EMERGENCY** arise, I authorize the medical staff to sedate <animal> and/or perform such emergency procedures as may be necessary for the health of <animal> until I can be notified. I agree to pay, in full, all charges for necessary services rendered for and to <animal>.

The clinic is to use all reasonable precaution against injury, escape, or death of <animal>. The clinic and staff will not be held liable for any problems that develop provided reasonable care and precautions are followed. I understand that any problem that develops with <animal> will be treated as noted above and I assume full responsibility for the treatment expense incurred.

I understand that the clinic is not responsible for loss or damage to personal items left with the pet including but not limited to leashes, collars, toys, and bedding.

To my knowledge, my dog does not climb over fences._____

I will call if my "pick-up date" changes so you can plan accordingly. If I neglect to pick up <animal> within 5 days of the date scheduled for discharge, and do not notify you within that time period, you may assume that <animal> is abandoned and are hereby authorized to dispose of <animal> as you deem best and/or necessary.

I have been provided with a copy of the boarding policy handout/brochure explaining boarding policy and regulations.

I understand there is an additional charge for any pet deemed aggressive during the boarding period.

I understand that this boarding consent form remains in full force and effect until Mulberry Grove Animal Hospital, Inc. receives written notification to the contrary and that it shall be binding on any future boarding arrangements.

Boarding At Mulberry Grove Animal Hospital

Thank you for choosing Mulberry Grove Animal Hospital to be "home" for your pet while you are away. We understand that each animal has very different needs. We are committed to meeting your animal's needs during their stay with us. Here at Mulberry Grove Animal Hospital, we are able to offer doctor-supervised boarding and grooming facilities. Our goal is to provide a safe, comfortable, and caring place for your pet while in our care. Our facility combines warmth and compassion, provided by our highly trained staff, to make your pet's stay a pleasing experience. We can provide long stays, or just day care for the attention your pet craves while you're away.

Our boarding facility is completely indoors with central air conditioning and heating to provide a consistent comfortable climate 24 hours a day. Kennels and runs are available so that your pet may be placed in the enclosure that is appropriate for its size. Alternatively, you may request an upgrade in the size of the enclosure for a nominal fee.

We encourage you to bring your pet's regular food while staying with us. Alternatively, we provide top quality Royal Canin GI Low Fat dog food. Fresh water is available at all times. We will administer your pet's medications (prescription or OTC) exactly as directed by you. Your pet's quarters are kept clean and sanitized, and dogs are walked a minimum of four times daily. Bowls and bedding are provided.

To keep our kennel parasite free all animals are given a Capstar® pill to rid them of fleas and a stool sample is taken to check for intestinal parasites. If internal parasites are found, a physical will be performed and your pet will be dewormed and if ticks are found a single dose of Nexgard given or Frontline Plus will be applied.

All pets must have proof of current vaccinations when staying with us, this includes RV, DHPP, Bordetella and CIV. *If vaccines are overdue at the time of boarding we will not be able to admit your pet for a minimum of 2 weeks after vaccines have been administered.* We encourage you to bring your records with you or call ahead to have records sent to us prior to boarding reservation.

Accommodations for weekend pick ups during non-business hours can be made when the bill is **pre-paid**. Drop off and pickup times are **8:30-8:45am** and **5:30-5:45pm** Saturday and Sunday. There is a charge of **\$16.00 for this convenience**.

For pets with medications, there is a charge of **\$1 per medication/per day**.
